The New Zealand Traveller Declaration collects travel, customs, immigration and biosecurity information. It aims to improve the safety and security of New Zealand.

It is available for travellers arriving into New Zealand's international airports.



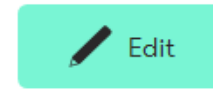

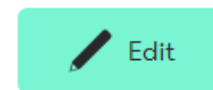

You do not need to print the email or fill in a paper arrival card. Your declaration will be automatically checked when your passport is scanned at passport control in New Zealand.

You can use your reference number to view or update your online declaration at any time up until you reach passport control in New Zealand. After passport control you can no longer make any changes to your declaration online. If you need to, you can verbally update your declaration about biosecurity items to a biosecurity officer.
