Alert 01 (Effective from 25.05.2026)

1. With effect from 25.05.2026, nationals of the following 40 countries are eligible to obtain tourist visa (ETA) free-of-charge for a period of 30 days.

2. Nationals of the above-mentioned countries holding Diplomatic, Official, Service, or Ordinary passports are eligible to obtain tourist visa (ETA) free-of-charge under this scheme.

3. Please note that **all foreign nationals, including nationals of the above-mentioned 40 countries** and nationals with bilateral reciprocal agreements between between (i.e. **Maldives, Seychelles, and Singapore**), are required to obtain an Electronic Travel Authorization (ETA) prior to arrival in Sri Lanka. As per the bilateral reciprocal agreement between Sri Lanka and Maldives, Maldivian nationals will receive 90 days tourist visa through ETA system.

4. The Electronic Travel Authorization (ETA) for nationals of the above-mentioned 40 countries nationals of **Maldives, Seychelles and Singapore** will be processed free of charge. **However, ETA fee paid by the applicants prior to 25.05.2026 are non-refundable**

5. Under this scheme, tourists are entitled to a free visa valid for 30 days (Maldivian nationals will receive 90 days), with double-entry facility permitted from the date of first arrival in Sri Lanka within the 30-day validity period.

1. All ETA holders should be able to prove:

- (i) A round trip ticket to show at the port of entry in Sri Lanka (only if you are traveling by air).
- (ii) Evidence of sufficient funds to cover your expenses in Sri Lanka.

2. **Employment:** Holder of ETA, should not engage in any form of employment, paid or unpaid, or in any trade or business other than specified in the ETA, during the period of his/her stay in Sri Lanka

3. **Fees and Payments:** You agree that your credit card(s) will be billed immediately after submission of your application. Requirements and Fees related to processing of your application are subject to change from time to time and you agree that the ETA processing fee once paid by you is not refundable and not transferable.

4. **Communication:** By using this site, you do authorize the Department of Immigration & Emigration Sri Lanka to contact you via e-mail, messaging, or any other electronic or non-electronic means of communication.

5. **Accuracy:** By submitting your application, you do certify that the information provided by you is true and correct.

6. **Limitations of use:** You may not use this site for any purpose other than the intended purpose.

(1) Application Submitting Terms

- You must enter the passport number correctly
- You must enter nationality correctly as appears in the travel document
- You must enter your date of birth correctly

You must recheck / crosscheck above information to ascertain that they have been entered correctly. You are required to pay for the visa again on arrival in case of any inconsistency in above particulars.

You must make sure that the same travel document which was used for applying online visa is used for entering into Sri Lanka. In the event you produce a travel document other than the one used for applying online visa, you are required to pay again on arrival for the visa.
