

## Veiledning for visumsøknad til India (e-Tourist Visa)

Her kan du få hjelp til hvordan du fyller ut visumsøknaden før reisen til India. Det er viktig at du følger denne veiledningen nøye.

For å søke om visum, trenger du følgende:

### 1. Pass

Passet ditt må være gyldig i minst 6 måneder etter hjemreisedatoen fra India. Når du fyller ut visumsøknaden, må du bruke en kopi av fotosiden i passet ditt. Denne må lastes opp elektronisk, så du bør ha passkopien klar på datamaskinen. Filen med passkopien skal være en PDF-fil og må maksimalt være 300 kb.

### 2. Passfoto

Du må bruke et passfoto, som skal lastes opp i forbindelse med utfylling av visumsøknaden. Derfor må du ha fotoet elektronisk på datamaskinen din. Fotoet skal oppfylle de gjeldende kravene for passfotos, det skal være i farger og ikke eldre enn 6 måneder. Fotoet skal være en JPG-fil og må maksimalt være 1 mb.

### 3. Søknadsskjema

Det må fylles ut én søknad for hver søker elektronisk på internett. Opplysningene i visumsøknaden må være helt i samsvar med opplysningene i passet ditt. Alle for-, mellom- og etternavn må oppgis nøyaktig som de står i passet. Du må ikke utelate noen navn eller skrive eventuelle kallenavn.

Det finnes tre forskjellige typer eTourist Visa med ulik varighet og pris.

30-dagers visum - 25 dollar

1-års visum - 40 dollar

5-års visum - 80 dollar

Hvis du velger 30-dagers visum, må du sende inn visumsøknaden senest 25 dager før ankomstdatoen til India. Hvis du velger 1-års eller 5-års visum, gjelder visumet fra den dagen du sender inn søknaden. Sørg derfor for at både ankomst- og avreisedato er innenfor visumperioden.
