Skjemaet som kalles PLF-skjema kan tidligst utfylles 72 timer før avreise. Vær oppmerksom på at avreisebrevet ditt fra oss inneholder informasjon som f.eks. hotelladresse, som skal brukes for å kunne utfylle skjemaet.





iii) in the case of a third or subsequent such offence, to a fine not exceeding €5,000 or imprisonment for a term not exceeding 6 months or both
