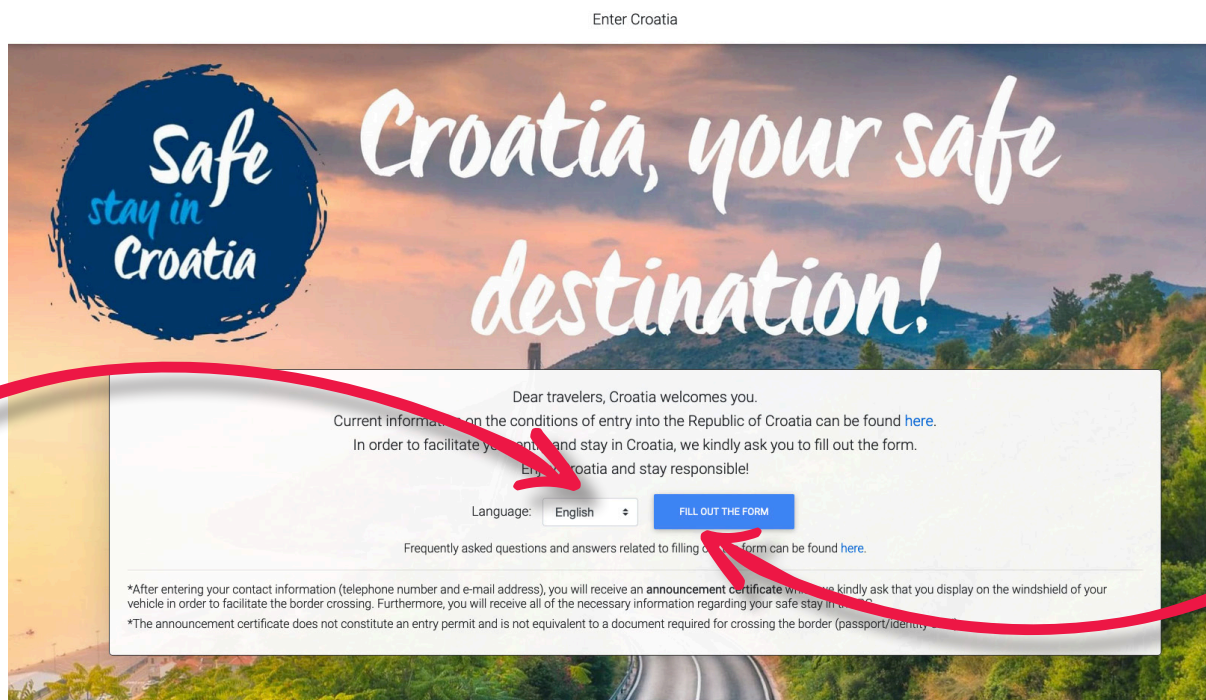

The fulfilment of the conditions for entry into the Republic of Croatia is directly decided by the police officer at the border crossing point when conducting border checks!

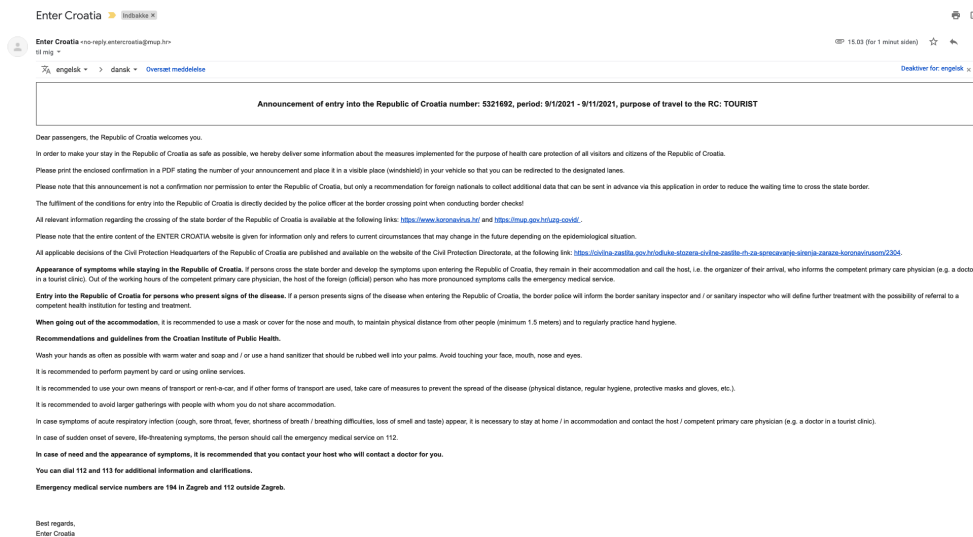
