* The overseas market value means a normal retail price (purchase price) abroad.
* When the price of an article exceeds 200,000 yen, duties and/or taxes will be imposed on its entire value.
* For articles excluding alcoholic beverages, tobacco products and perfumes, articles with a total overseas market value of 10,000 yen or less per item are duty free in principle.
* As for children under 8 years old, duty-free allowances are limited to the articles owned for their personal use.
