

# Vägledning för visumansökan till Indien (e-Tourist Visa)

Här kan du få hjälp med hur du fyller i din visumansökan inför din resa till Indien.

Det är viktigt att du följer denna vägledning noggrant.

För att ansöka om visum behöver du följande:

## 1. Pass

Ditt pass måste vara giltigt i minst 6 månader efter ditt hemresedatum från Indien. När du fyller i din visumansökan behöver du en kopia av fotosidan i ditt pass. Den ska laddas upp elektroniskt, så du måste ha passkopian redo på din dator. Filen med passkopian måste vara en **PDF-fil** och får **max vara 300 kb** stor.

## 2. Passfoto

Du behöver ett passfoto som ska laddas upp i samband med visumansökan. Därför måste du ha fotot elektroniskt på din dator. Fotot ska uppfylla de gällande kraven för passfoton, det ska vara i färg och får inte vara äldre än **6 månader**. Fotot måste vara en **JPG-fil** och får **max vara 1 MB**.

## 3. Ansökningsformulär

En separat ansökan ska fyllas i elektroniskt på internet för varje sökande. Uppgifterna i visumansökan måste **exakt** matcha uppgifterna i ditt pass. Alla förnamn, mellannamn och efternamn ska anges precis som de står i passet. Du får **inte** utelämna något namn eller använda smeknamn.

Det finns tre olika typer av e-Tourist Visa med olika giltighetstider och priser:

- 30 dagars visum – 25 USD
- 1 års visum – 40 USD
- 5 års visum – 80 USD

Om du väljer **30 dagars visum** ska du ansöka **tidigast 25 dagar** innan ditt ankomstdatum till Indien. Om du väljer **1 eller 5 års visum**, gäller visumet från dagen du skickar in ansökan. Se därför till att både ditt ankomst- och avresedatum ligger inom visumets giltighetsperiod.
