iii) in the case of a third or subsequent such offence, to a fine not exceeding €5,000 or imprisonment for a term not exceeding 6 months or both

I declare I fully understand all the above information, and should I make any false declarations or not have the required evidence to prove any declaration made, I could be liable for a fine not exceeding €5,000 or imprisonment for a term not exceeding 6 months, or both.
